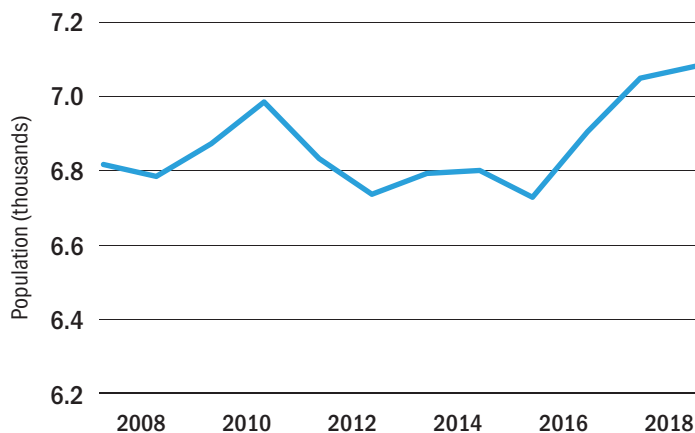




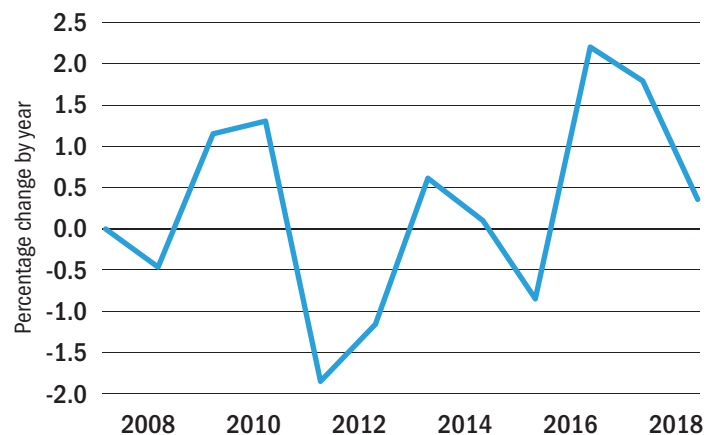

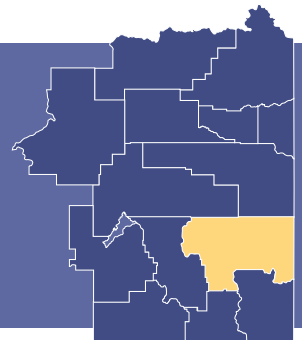

Population Percentage Change

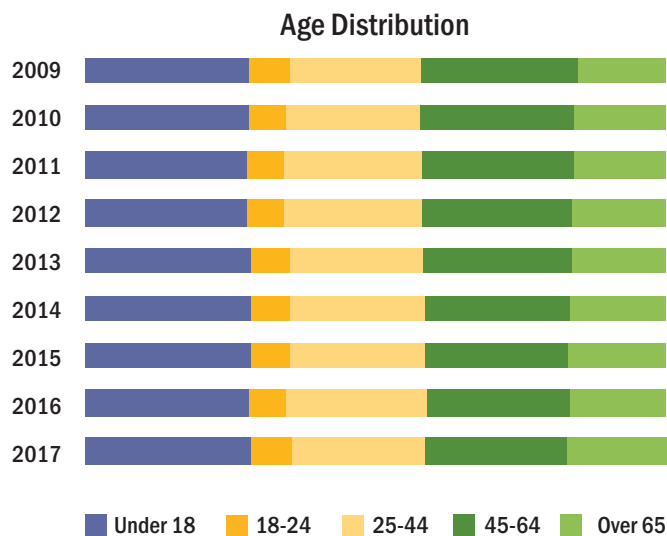

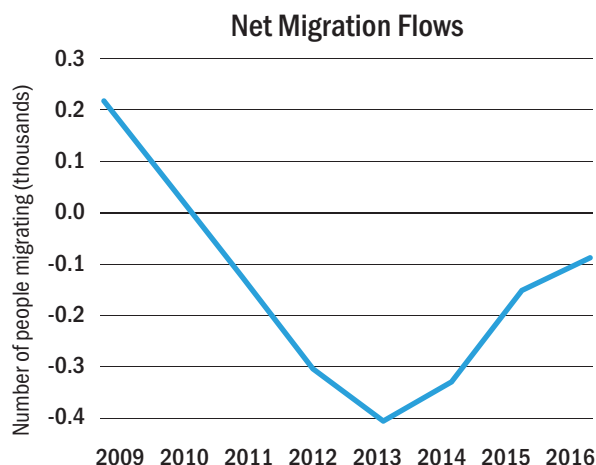

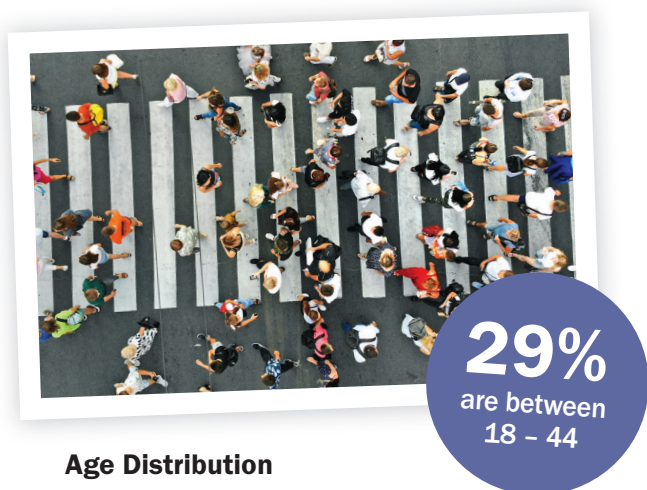

Age Distribution

Caribou County's age distribution has remained fairly constant for all age groups from 2009 to 2017. The age groups of over 65 and 45-65 have seen the most change from 2009 to 2017.

Net Migration Flows

In 2009, more than 200 people were moving in to Caribou County. That number has decreased to the point that more people are migrating

away from Caribou County. In 2013, 404 people migrated out of Caribou. Since then, fewer and fewer people are leaving the county.

Employment

Key Industries

Caribou's top five industries are Manufacturing; Construction; Retail Trade; Educational Services; and Agriculture, Forestry, Fishing & Hunting. These industries employ the largest percentage of the workforce in the county. However, some industries that have experienced a positive growth in the workforce that are not included in the top five are Utilities and Accommodation & Food Services.

From 2013 to 2017, the number of people working in the Utilities and Accommodations & Food Services industries have both increased by 97%.

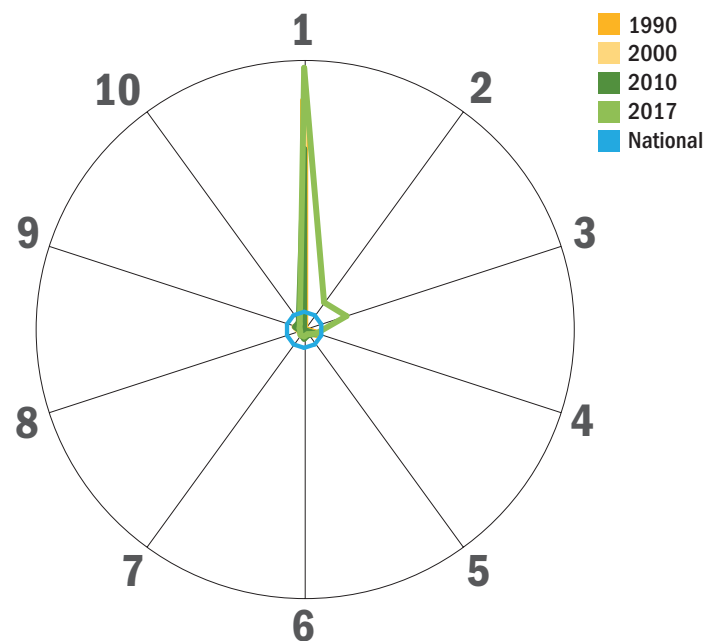

Location Quotients

A location quotient shows the industry's share of an area's employment relative to the national average. For example, a location quotient of 2.0 indicates that an industry accounts for twice the share of employment in the area than it does nationally, and a location quotient of 0.5 indicates the area's share of employment in the industry is half the national share.

Education

As of 2017, 30% of the population over 25 years of age had some sort of college degree.

From 2009 to 2017, the percentage of people over 25 years of age having a bachelor's degree increased from 14% to 15.3%, respectively. A significant change is more and more people are going to college and ending up with no degree.

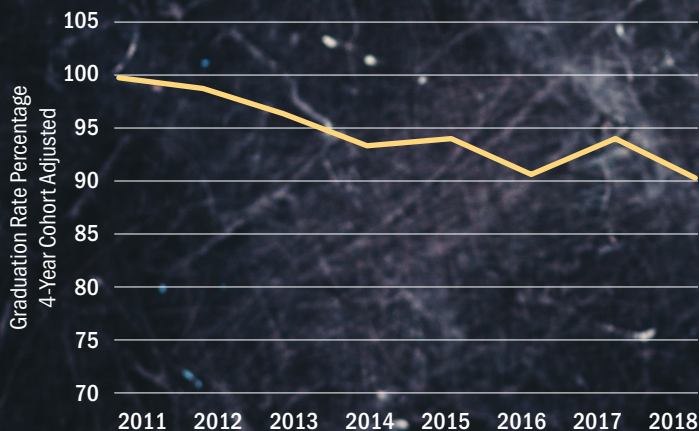
While the population over 25 years of age with only a high school diploma or less is decreasing, more people are working towards some sort of college degree, showing a shift towards higher education.

HIGH SCHOOL GRADUATION RATES

The high school graduation rates from 2014 to 2018 were calculated by doing a weighted average of the graduation rates for the school districts in Caribou County.

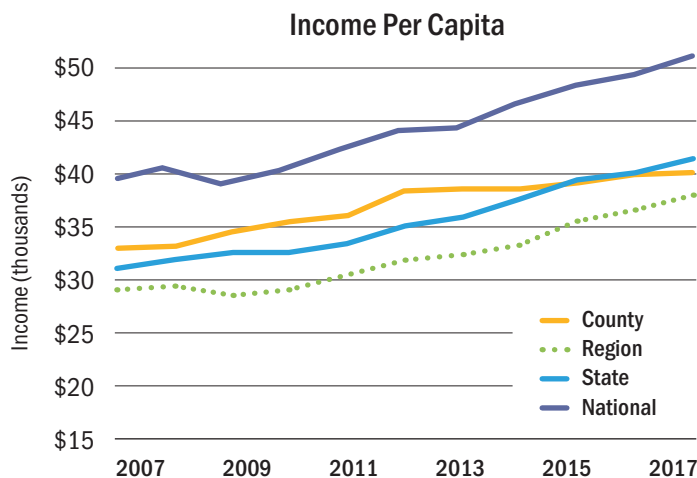
Graduation rates decreased from 94.62% to 90.99% from 2014 to 2017.

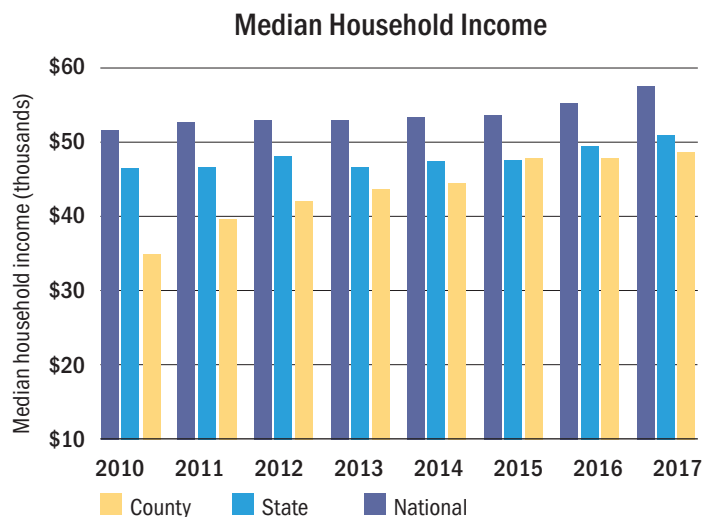
Median Household Income

As of 2017, half of the population earned an annual income above \$58,750 and the other half earned an annual income below \$58,750. This number has grown by 30.7% since 2010. Caribou County's median household income is growing at an average rate of 4% per year, and it is higher than the state's, and has been higher than the nation's since 2013.

Poverty Level

The poverty level in Caribou County has increased slightly from 2012 to 2017 from 7.7%



to 9.4%, respectively. In 2016 the percent of people under the poverty level reached its highest at 10.2%. The weighted average for people living under the poverty level from 2012 to 2017 is 8.8%.

Unemployment Rate

The unemployment rate for Caribou County is lower than the unemployment rate for the nation, the same as the state, but it is higher than the one for the region. The recession in 2008-2009 explains the peak in 2009-2010. The 2018 unemployment rate for Caribou County was 2.8%.

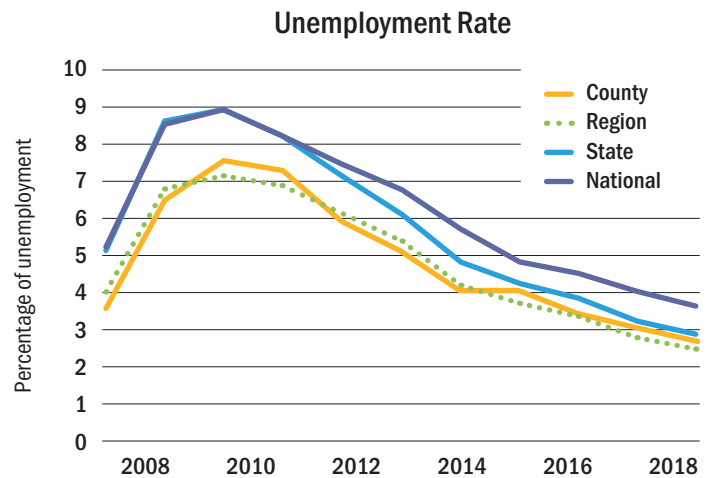
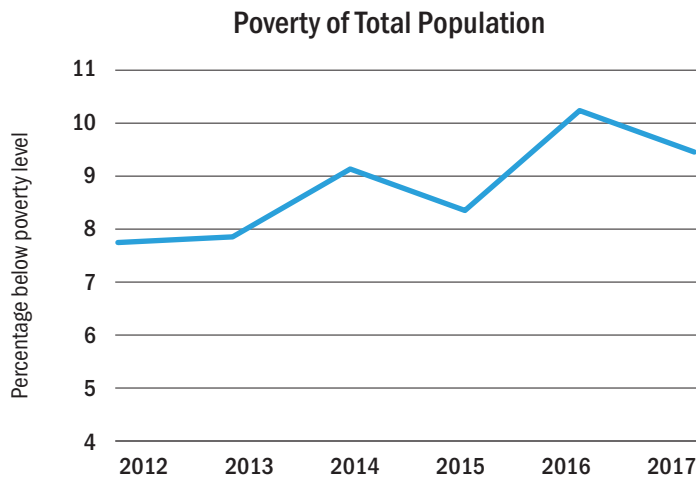

Median Home Value

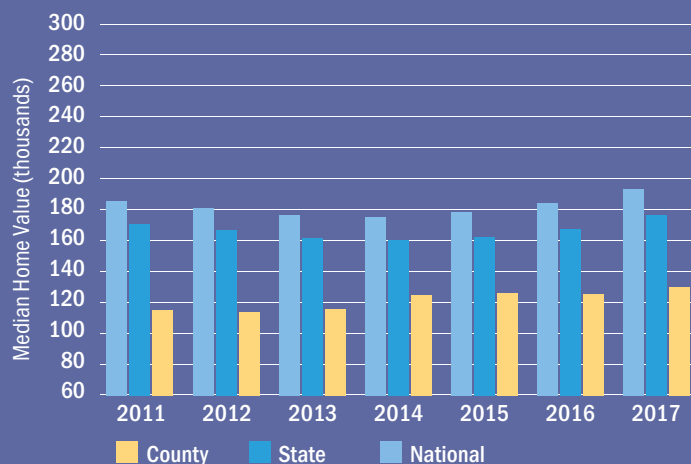

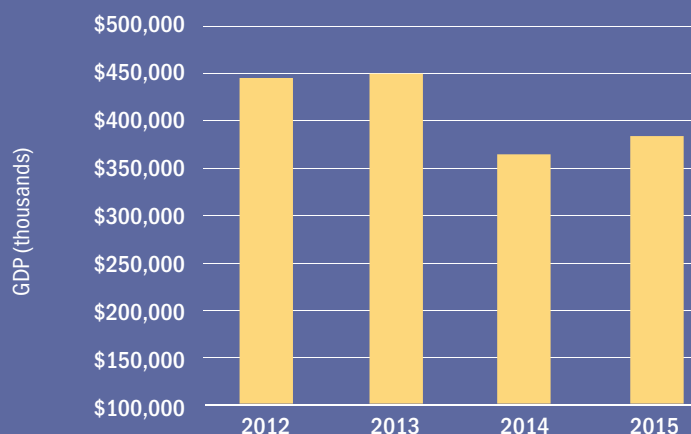
Gross Domestic Product
