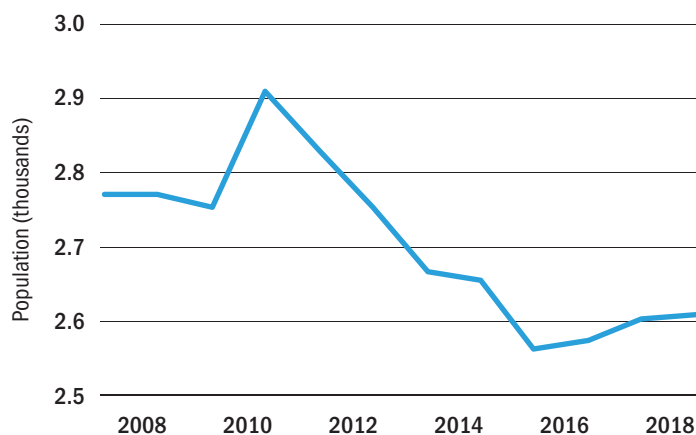




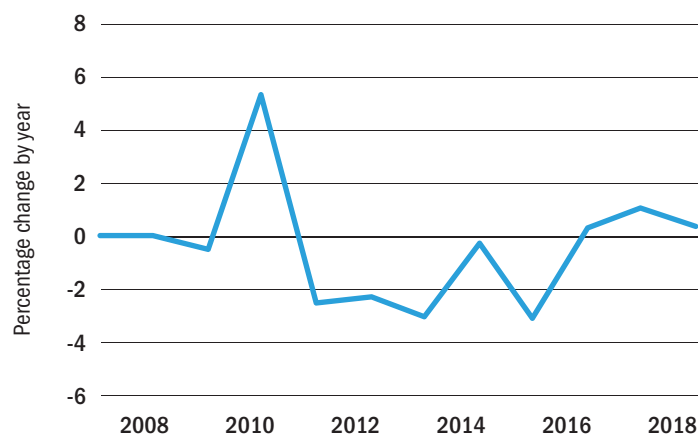

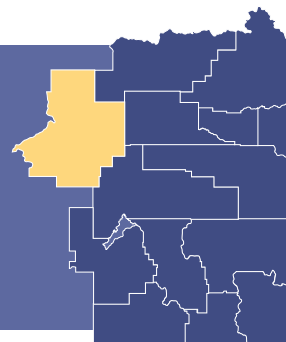
Resident Population



Population Percentage Change

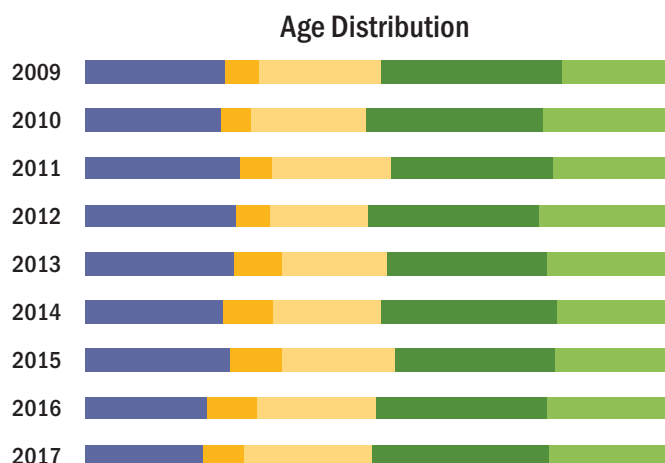

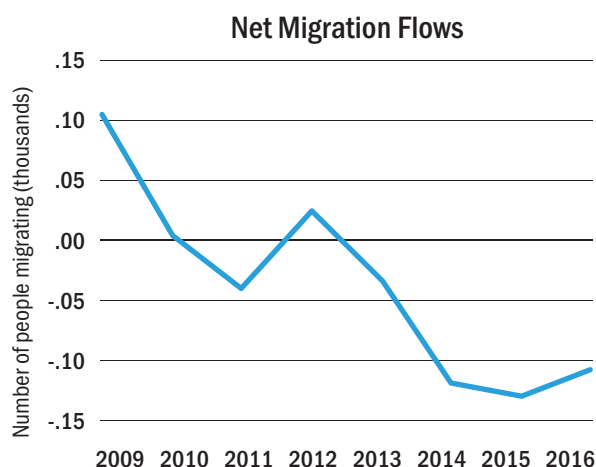

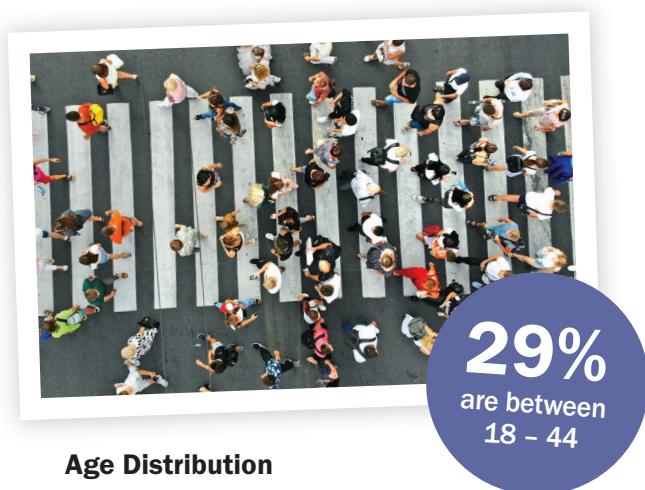

Age Distribution

Butte County's age distribution has remained fairly constant for most age groups from 2009 to 2017. The age group from 24 years and younger has dropped from 30% in 2009 to 27.4% in 2017, indication that the distribution of age is growing older.

Net Migration Flows

In 2009, over 100 people were moving in to Butte County. That number has decreased significantly to where more people are migrating away from the county.

Employment

Key Industries

Butte's top five industries are Agriculture, forestry, fishing, & hunting; educational Services; Retail Trade; Public Administration; and Health care and Social Assistance. These industries employ the largest percentage of the workforce in the county. However, some industries that have experienced significant positive growth in the workforce that are not included in the top five are Accommodation and Food Services, and Construction.

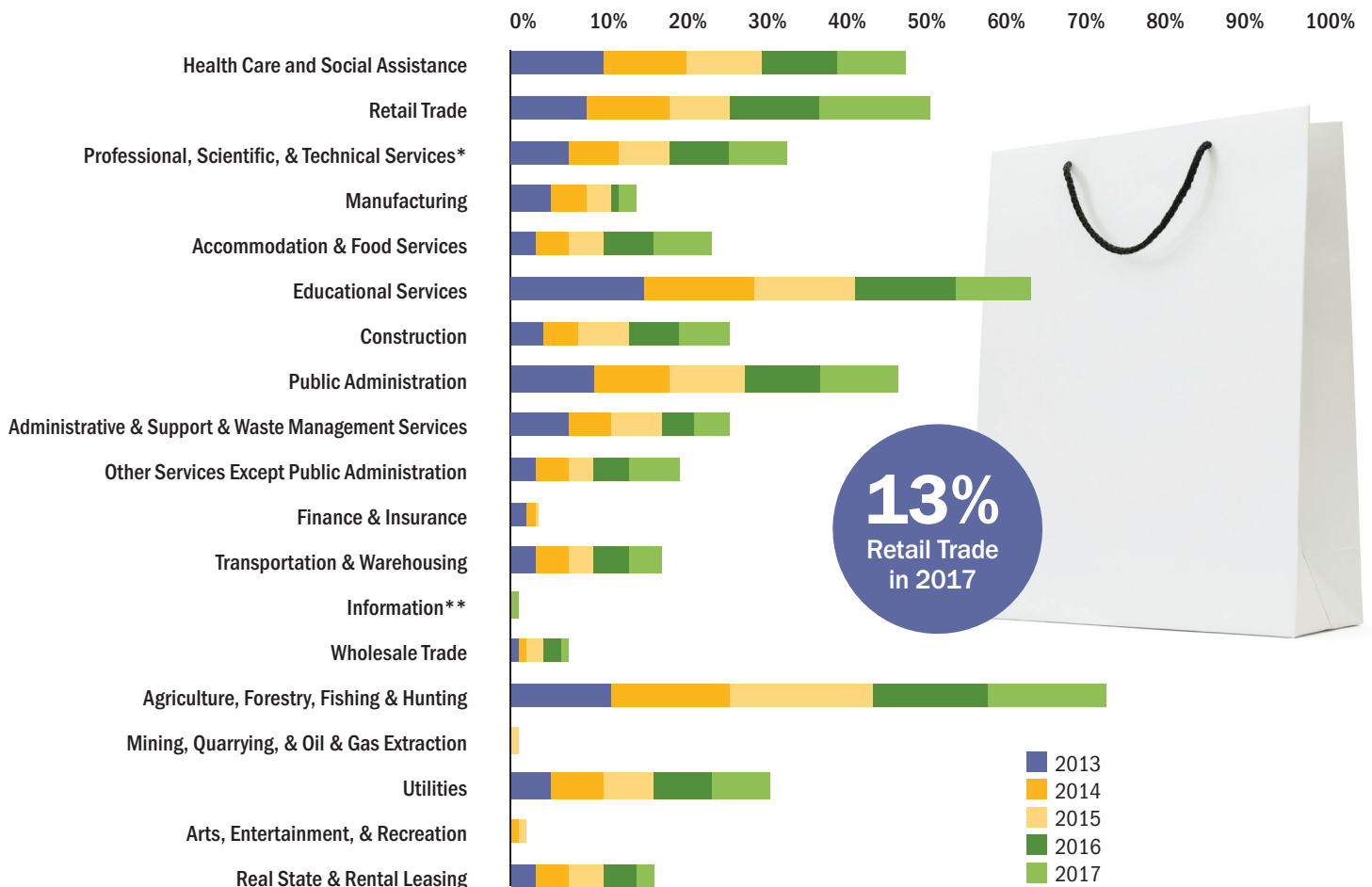
From 2013 to 2017, the number of people working in the Accommodations & Food Services and Construction industries has increased by 121% and 42%, respectively.

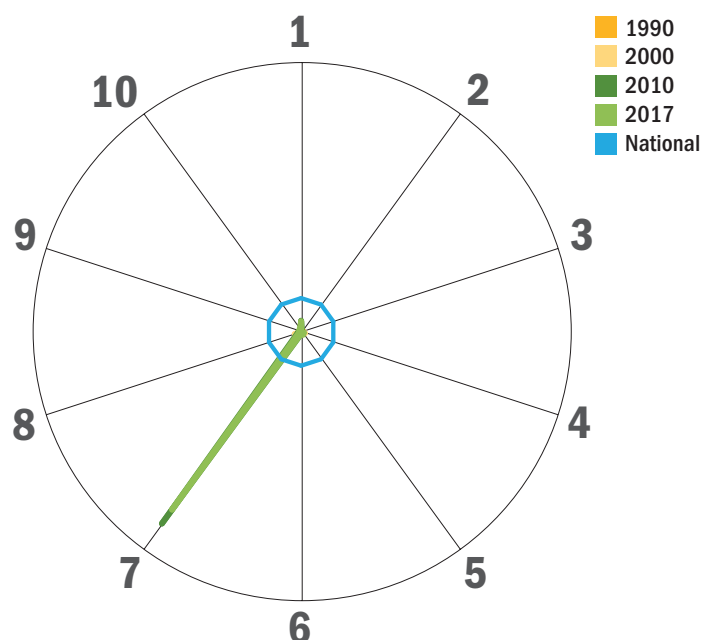

Location Quotients

A location quotient shows the industry's share of an area's employment relative to the national average. For example, a location quotient of 2.0 indicates that an industry accounts for twice the share of employment in the area than it does nationally, and a location quotient of 0.5 indicates the area's share of employment in the industry is half the national share.

Education

As of 2017, 24.8% of the population over 25 years of age had some sort of college degree.

From 2009 to 2017, the percentage of people over 25 years of age having a bachelor's degree or higher has decreased from 18.4% to 15.5%, respectively.

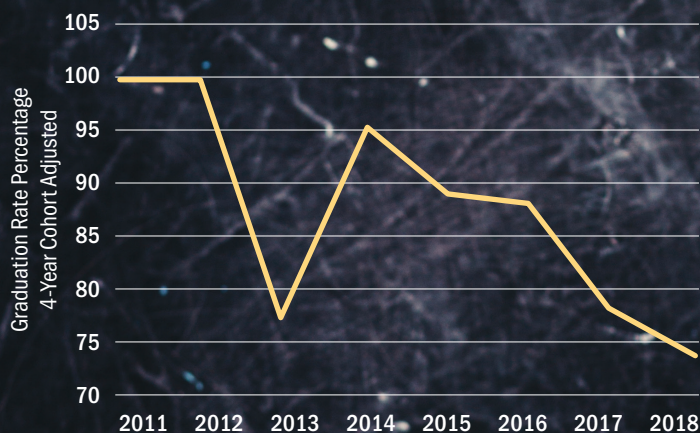
From 2013 to 2017, the county has seen a consistent growth in the population with some type of degree.

HIGH SCHOOL GRADUATION RATES

The high school graduation rates from 2014 to 2018 were calculated by doing a weighted average of the graduation rates for the school districts in Butte County.

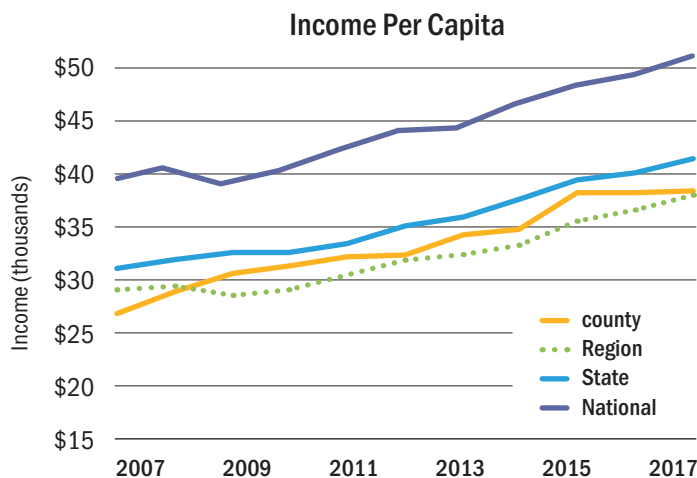
Graduation rates have decreased from 89.5% to 74.1% from 2014 to 2017.

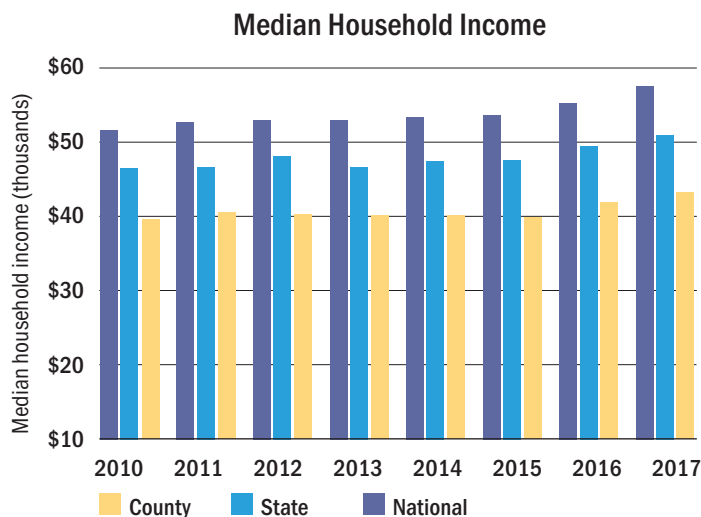
Median Household Income

As of 2017, half of the population earned an annual income above \$43,207 and the other half earned an annual income below \$43,207. This number has grown by 9.6% since 2010. Butte County's median household income is growing at an average rate of 1.5% per year.

Poverty Level

The poverty level in Butte County has increased slightly from 2012 to 2017 from 14.3% to 16.2%, respectively. In 2015, the percent of people under the poverty level reached its highest to 17.6%.



The weighted average for people living under the poverty level from 2012 to 2017 is 15.8%.

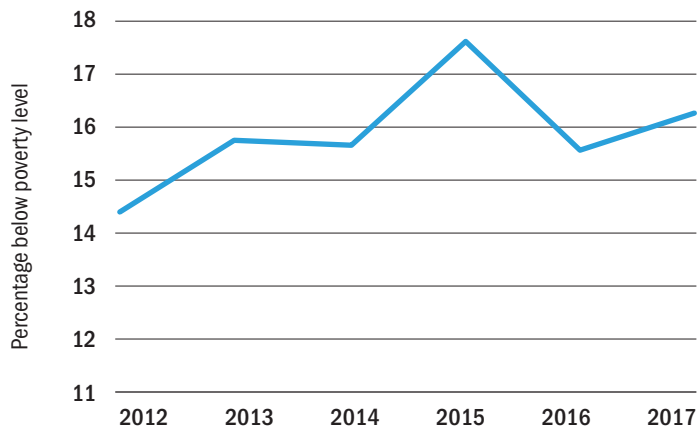
As of July 2018, Butte County had 1,049 households with an average of 2.45 individuals per household.

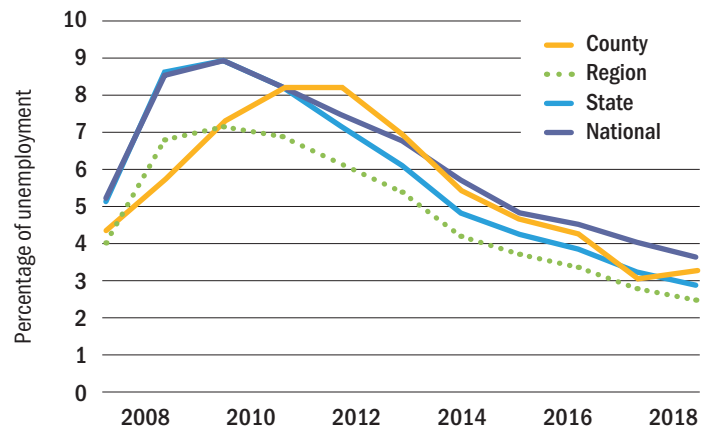

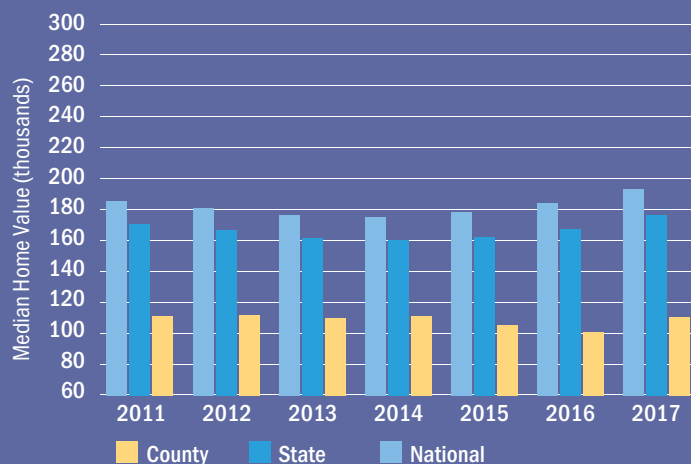

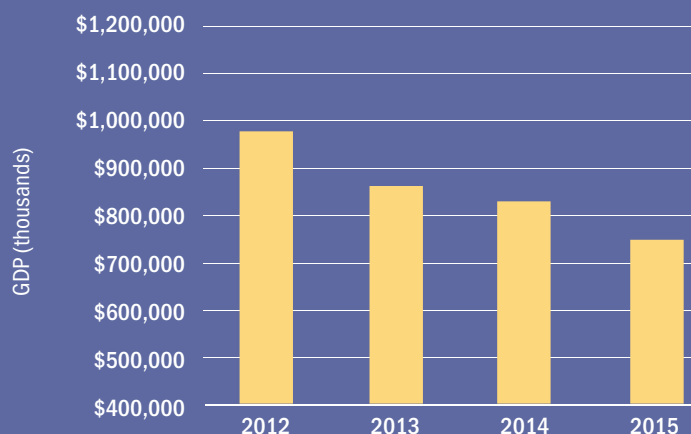
Gross Domestic Product
